

Slaughter Poultry in low age and weight

According to a report, it is decided to slaughter poultry in low age and weight from 21 Nov. 2016. All of the integrated companies are cooperating in this plan.

Animal affairs Assistant of Agriculture ministry, Poultry and broiler cooperatives and other companies support the plan. It is to prevent the producers losses and to reduce the wastes in heavy birds. Other benefit of this plan is declining the food in farms.

Before this, because of the market problems and the price fluctuations, heavy broilers with more than 2/5 kg were sent to the markets. By this way, customers suffered many losses. From 21. Nov. 2016 the broilers will supply less than 2 kg.



Dear Minister, take a look in water Darkroom!



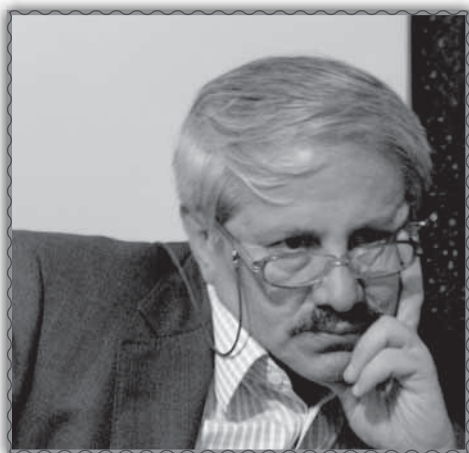
In this essay, writer points out to dual indexes in government and prevent to make illogical decisions on government activities about new irrigation systems.

WTO in international trade.

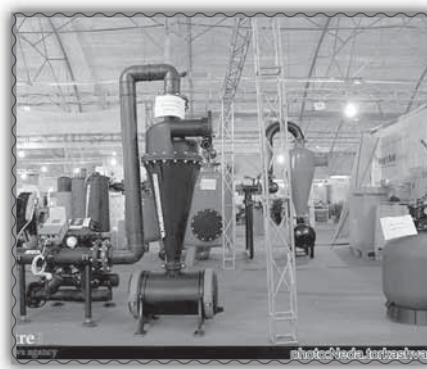
He has written, regarding to Iran has not accepted in WTO, to success such policies, government must act through its embassies in other countries.
